Department of Ecology and Environment of Jiangsu Province Held On-Site Conference of “Full Lifecycle Monitoring System of Hazardous Waste” in NU ENVIRO’s Subsidiary

(17 December 2020, Hong Kong) From 15 to 16 December, 2020, in order to improve and upgrade the Full Lifecycle Electronic Monitoring Management System of Harzadous Waste at provincial level, Department of Ecology and Environment of Jiangsu Province held the on-site promotion conference of “Full Lifecycle Monitoring System of Harzadous Waste” in Zhenjiang. The conference was attended by approximately 240 environmental protection managers from government departments of all cities, counties and chemical industry parks in the province.

On 15 December, during the conference, participants arrived in batches to **Zhenjiang New Universe Solid Waste Disposal Co. Ltd.**, a subsidiary of **New Universe Environmental Group Limited** (“NU ENVIRO” or the “Company”, stock code: 436.HK) under the guide of leaders of Provincial Department of Ecology and Environment. They observed and investigated the whole process of electronic management of the disposal end in the Full Lifecycle Monitoring System of Harzadous Waste.

Ms. Liu Yuan, Deputy General Manager of the Group and Mr. Gu Lin, Chief Engineer introduced the electronic management of disposal end of NU ENVIRO to inspectors through video transmission and ERP electronic management system on the site.

After the conference, NU ENVIRO will continue to participate and cooperate with the Provincial Department of Ecology and Environment to upgrade the electronic data development and complete docking of the waste and disposal end, and the waste end generated for the full lifecycle of hazardous waste, in order to truly realize the full lifecycle of hazardous waste electronic management in provincial level. In the meanwhile, NU ENVIRO will upgrade its ERP electronic management system of hazardous waste of the current subsidiaries at the beginning of 2021 to enhance the integrated management of data and video flow of hazardous waste at the disposal end.
